<b>Policy Loans</b>	Only under Deferred Life Annuity option, Policy Loans will be available during deferment period subject to such terms and conditions as the company may specify from time to time.	
<b>Free Look in period</b>	15 days from the date of receipt of the original policy document. If you have purchased your Policy through Distance Marketing this period will be 30 days. If the vesting pension policy has a mandatory annuitisation clause, you can only change options within HDFC Life Pension Guaranteed plan or switch to HDFC Life New Immediate Annuity Plan during the free-look period.	
<b>Surrender</b>	<p>Surrender Benefits are available only for Immediate and Deferred Life Annuity with Return of Purchase Price (Single and Joint life option):</p> <p>Surrender Value shall be equal to the Present Value (PV) of expected future benefits discounted at the then prevailing interest + 2%. Details of Surrender Value computation has been outlined in the Policy Document.</p> <p>For the purpose of computing the surrender benefits, the purchase price excludes applicable taxes and other statutory levies, if applicable. Upon payment of the surrender benefit the policy shall terminate and all other benefits shall cease.</p>
